A call for tenders for one (1) research grant for a post-doctoral research fellow is currently open in the research unit Instituto de Estudos Medievais (IEM)-NOVA FCSH (UIDP/00749/2020) financed by Portuguese national funds (FCT/MCTES – PIDDAC), under the following conditions:

Main Scientific Area: Arts and Humanities

Sub Research field: Medieval Studies (History / Archaeology / Art History /

Literature)

## **Entry requirements:**

- PhD obtained less than 3 years before the date of submission, in any of the following domains: Medieval Studies; History; Archaeology; Art History; Literature
- Research leading to the PhD having been conducted at an institution other than IEM-NOVA FCSH

**Work plan:** The grant holder's research will integrate the stategic plan of IEM-NOVA FCSH for the period 2020-2023 (as found in

https://iem.fcsh.unl.pt/imagens/files/Projeto%20Estrat%C3%A9gico%20do%20IE M%2C%202020-2023.pdf, section 14.2), by proposing a three-year research project and work plan, for the duration of the grant. The topic will be chosen from within the following research areas:

- 1. Medieval Lisbon:
- 2. The sea and coastal towns:
- 3. Religious and/or military architecture in medieval Portugal;
- 4. Jewish studies: Portugal.

**Applicable legislation and regulations:** Research Fellow Status; Regulation of Research Grants of the Fundação para a Ciência e a Tecnologia, I.P. (https://www.fct.pt/apoios/bolsas/docs/RegulamentoBolsasFCT2019.pdf)

**Workplace:** The work will be carried out at Instituto de Estudos Medievais (Faculdade de Ciências Sociais e Humanas, Universidade Nova de Lisboa) and/or other locations necessary for the development of the research project and work plan under the scientific guidance of up to three supervisors, previously agreed with the candidate; a least one of whom being an integrated member with PhD.

**Duration of the grant:** The scholarship will be for twelve (12) months, expected to begin in July 2021, renewable until 36 months.

Monthly maintenance allowance: The grant amount corresponds to 1 616,00 €, paid monthly by bank transfer, according to the table of scholarship values directly attributed by FCT, I.P., in the country (http://www.fct.pt/apoios/bolsas/valores). To this value is added a personal accident insurance, and and optional voluntary social insurance at the first level.



Selection procedure: Curriculum assessment (AC) + Interview (E).

## The candidates will be assessed and rated according to the following criteria:

- 1.1. Academic training (25%):
- Undergraduate (10%);
- Master's (5%);
- Doctoral (10%) degrees.
- 1.2. Scientific merits (30%):
- Publications (Books; book chapters; journal articles; other) (15%);
- Additional curricula (e.g., participation in research projects; conference organization and participation; posters; portfolios; other) (15%);
- 3. Research project and work plan (30%);
- 4. Motivation letter (5%);
- 5. Interview (10%).

The criteria will be valued in a scale from 0 (zero) to 100 (one hundred) points. Candidates ranked below 70 will be ineligible for the grant.

**Form of publication / notification of results:** The final results of the evaluation will be communicated by email, as per the Regulation of Research Grants of the Fundação para a Ciência e a Tecnologia, I.P., art. 12.

The minutes of the selection procedure will be made available for public consultation.

Once the results have been published, candidates if they so wish will have up to 10 working days to make their views known in the terms of a prior hearing, in accordance with the Administrative Procedure Code. The final decision shall be taken no later than 60 working days after the conclusion of the prior hearing of interested parties or of the public consultation.

The final decision may be contested within 15 working days, and an appeal to the maximum executive body of the funder within 30 working days, in both cases counting from the notification date.

Application deadline and form of submission of applications: The competition is open from 25 of March until 26 of April, 2021.



Applications must be submitted by email with the following documents attached: a. BA, MA, PhD certificates; b. Curriculum vitae arranged according to criteria as described in 8.2; c. Research project and work plan for 36 months; d. Letter of motivation.

In the case of academic degrees obtained outside Portugal, recognition of degrees obtained in accordance with DL Nr 66/2018, 16 August, is required; or a declaration of honor that the recognition document will be submitted before the grant starting date. The submission of the recognition document before the grant contract is celebrated date is compulsory.
